

## Schnucks Taste of Italy Sweepstakes

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. THIS SWEEPSTAKES IS INTENDED ONLY FOR LEGAL RESIDENTS OF ILLINOIS, INDIANA, IOWA, MISSOURI, AND WISCONSIN WHO ARE 21 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. YOU MUST HAVE ACCESS TO A COMPUTER WITH INTERNET ACCESS IN ORDER TO ENTER.

1. **ELIGIBILITY:** The Schnucks Taste of Italy Tickets Sweepstakes is only open to legal residents of the states of Illinois, Indiana, Iowa, Missouri, and Wisconsin who are 21 years of age or older as of the time of entry. The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Employees, directors, and officers of Schnuck Markets, Inc. and their respective parents, affiliates, subsidiaries, advertising, and promotional agencies involved in this Sweepstakes (collectively, "Released Parties"), and each of their immediate family members (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same household of each are not eligible. 2. **SWEEPSTAKES PERIOD:** Sweepstakes begins on Wednesday February 22, 2017 at 12:00:01 a.m. CT and ends at 11:59:59 p.m. CT on Tuesday, March 14, 2017 (the "Sweepstakes Period"). The time stamp for the server for the entry application will be the official timekeeper for this Sweepstakes.

3. **TO ENTER:** During the Sweepstakes Period, visit any of the following web address [www.schnucks.com/TasteofItaly](http://www.schnucks.com/TasteofItaly) and follow the links and instructions to complete and submit the registration form, including providing a valid name, home address, phone number and e-mail address. Limit one (1) entry per person and/or e-mail address during the Sweepstakes Period. Automated means of entry are prohibited and any use of automated devices will cause disqualification.
