

## Schnucks 2023 Good for You Sweepstakes

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. 1. **ELIGIBILITY:** The Schnucks 2023 Good for You Sweepstakes is only open to legal residents of the states of Illinois, Indiana, Missouri, and Wisconsin who are (a) 18 years of age or older and (b) are members of the Schnucks Good for You program as of the time of entry. It is free to join Schnucks Good for You program by completing the registration process, which may be done at a participating Schnucks store, online at <https://nourish.schnucks.com/good-for-you/>, through the use of an app on your mobile device, or in such other manner as we may offer.
